[1] Seeing the Appellant's motion and the representations of the parties at the hearing;

THEREFORE, THE UNDERSIGNED:

- [2] **GRANTS** the motion in part;
- [3] **AUTHORIZES** the Appellant to increase the number of pages of its arguments, (Parts I, II, III and IV), from 30 to 40 pages;
- [4] **AUTHORIZES** the Respondent and the Impleaded party, Attorney General of Canada, to increase the number of pages of their arguments (Parts I, II, III and IV) from 30 to 40 pages;
